THE MiStra PROJECT

MiStra is a mainstreaming project aiming to involve policy makers, local authorities and public and private stakeholders on projects aimed at the integration of policies and targeted interventions (supporting for training, work insertion, cultural mediation, housing policies, etc.) identified as good practices at European level for the social inclusion of migrants, Roma and other minorities.

The project provides for the transfer of four good practices (from the cities of **Dublin**, **Berlin**, **Vienna** and **Bologna**) in four target cities (**Taranto, Burgas, Prague** and **Budapest**) on these issues.

The four best practices were chosen within the transnational partnership involved in the project, based on previous experiences of success on the theme of social inclusion, while the four target cities were identified on a needs analysis held by the partners of the cities involved, which stressed the need to implement measures of social inclusion for migrants, Roma and other minorities in their respective territories.

PROJECT OBJECTIVES

- To optimize the impact of education and training interventions aimed at migrants, Roma and other cultural minorities marginalized, to facilitate their work insertion and social inclusion, by coordinating and integrating the activities with the welfare system of the cities involved
- To make known to main policy makers, Managing Authorities of public funds and Local Authorities, the successful experiences carried out in favour of migrants and Roma people, by providing input on how best to develop a policy framework supporting the activities of local administrations and how to distribute public funds to support these experiences
- To gather around the same table all the stakeholders in the process of integration between training activities and the welfare system of the city, to improve the management capacity of networks and umbrella organizations of local development partnerships (Public Authorities, Local development Agencies, etc.) through a participatory approach
